When California-based **Natrol, Inc.,** a world-wide marketer and distributor of sports nutrition and related nutraceutical products, was sued in Federal Court in the Southern District of Florida, for breach of contract, it put its trust in **Sacher, Zelman, Hartman, Paul, Beiley & Sacher, P.A.,** and counter-sued the Florida-based nutraceutical manufacturer, **Nature's Products, Inc.,** for breaches of contract and related warranties, resulting from a **Class 1 FDA Recall** caused by the defective manufacturing of sports nutrition protein powders that contained Gluten and Wheat allergens, contrary to their Gluten-free and Wheat-free labels, and false certifications by the manufacturer.

After two years of hard-fought litigation and a two week trial, the Jury awarded Natrol \$3.27 Million in compensatory damages, and Natrol continues to seek the recovery of all of its attorneys' fees, non-taxable costs, and related expenses, pursuant to the parties' controlling Indemnity Agreement, as well as pre-judgment and post-judgment legal interest.
